## **BOOKING TERMS & CONDITIONS**

Effective from January 1, 2025

## **TOUR PAYMENT**

A 30% non-refundable deposit is due at time of booking to reserve your space.

The balance (70% of the total) is due two (2) months prior to the first land day of the trip. If booking is made within two (2) months of the first land day of trip, full payment is due at time of booking.

Payment is accepted by credit card or ACH transfer through our online payment portal. Credit card payments incur a 2.9-3.9% surcharge (depending on the card) due to additional bank processing fees.

It may also be possible to pay by international bank transfer through your bank (banks typically charge about \$50 for this service). **International bank transfers should be made in**<u>US Dollars</u> only (paying into our US Dollar account with any other currency will cause a shortfall in your payment due to a loss from the conversion process and you will be responsible for making up the shortfall with an additional payment).
