# TANZANIA'S E-VISA ONLINE APPLICATION PROCESS

We recommend applying for your e-visa **at least three weeks** before departure from your home country. Apply only through Tanzania's Immigration website listed below. Google Chrome is the recommended web browser for accessing the site.

Once approved, your visa should be emailed to you. If you haven't received an email after 7-10 days, log back in to the e-visa website to check the status there. Some guests have reported that they did not receive email notification and had to log in to the immigration website to get their visa. Download, print and carry the entire Visa Grant Notice PDF in your carry-on to present to the immigration officer when you arrive in Tanzania.

Please contact us if you haven't received your visa within 5 business days of your departure from your home country so that we may contact the immigration department.

### You may apply for an e-visa if entering Tanzania through any of these points of entry:

- Dar es Salaam Julius Nyerere International Airport (DAR)
- Kilimanjaro International Airport (JRO)
- Zanzibar Abeid Amani Karume International Airport (ZNZ)
- Namanga border crossing from Kenya
- Tunduma border crossing from Malawi

## HELPFUL INFORMATION FOR FILLING OUT YOUR E-VISA APPLICATION

**Note:** Each traveler, including children, will need to apply for a visa separately.

### Before You Start: Prepare Your Required Documents

As part of the application process, you'll be required to upload: 1) a recent passport size photo (JPEG or PNG, 300 KB or smaller); 2) the biodata/photo page of your passport (JPEG or PNG, 300 KB or smaller); and 3) your international round-trip ticket/flight confirmation showing your inbound and outbound flight details for Tanzania (PDF, 1 MB or smaller). You can DIY the passport size photo using your phone to take a good quality photo against a white wall that you can then crop to a square image.

**IMPORTANT:** Make sure your passport is valid for at least 6 months beyond your <u>last day</u> in Tanzania. You will need two blank passport pages for immigration to affix your visa and put your arrival and departure stamps. If you are traveling to any other countries before or after Tanzania, you will also need 2 blank pages available for each of those countries.

**US citizens** must apply for a multiple-entry visa at \$100 USD per person. Other nationalities may apply for a single-entry visa at \$50 USD, unless you will be departing Tanzania and returning again within one year.
